Summary of key findings for parents

The provision meets requirements

- The provider understands the value of evaluating her practice and has addressed the actions raised at the last inspection regarding safety and staff deployment.
- There is a suitable amount of toys and resources available for children to support their interests and complement their learning at school.
- The provider shows an awareness of how to manage and support children's behaviour. She works in partnership with parents and professionals to aid continuity of care.
- The provider contributes to children's health by offering them healthy snacks and drinks.
- The provider has a clear understanding of her roles and responsibilities to safeguard children. She ensures all staff have up-to-date child protection training to help them feel secure in the procedures to follow if they have any concerns about children's welfare.
- Robust recruitment processes, suitability checks and training opportunities are in place to ensure staff are suitable for their roles in working and caring for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the provider how she intends to deliver the educational programmes for early years children.

Daffodil (Nursery) After School Club registered in 2015 and is run by Daffodil Nursery Limited. It operates from The Pavilion in Long Hanborough, Oxfordshire, and is associated with Daffodil Nursery located in the same village. The club is open on weekdays during school term times from 3pm until 6pm. It offers a breakfast club from 7.30am until 8.30am on Monday to Thursday. There are six staff employed through the nursery to work in the club, including the registered provider, five of whom hold relevant qualifications at level 3 or 5.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
